- The Acquirers have entered into the Share Purchase Agreement ("SPA") with the Seller and the Target Company on June 22, 2023, for acquisition of 19.70,400 (Nineteen Lakhs Seventy Thousand Four Equity Shares ("Sale Shares") of ₹10/- each representing 35.92 % of the Equity Share Capital of the Target Company at a price of ₹20 (Rupees Twenty only) per Equity Share aggregating to ₹3,94,08,000 (Rupees Three Crore Ninety-Four Lakhs Eight Thousand Only), subject to the terms and conditions as mentioned in the SPA ("Underlying Transaction").
- Post consummation of the Sale Shares and assuming full acceptances in the Offer, the promoter shareholding will reach to 53,51,500 Equity Shares representing 97.57% of the Equity Share Capital of the Target Company. The Acquirers, who are the members of promoter group will collectively hold 45,78,240 Equity Shares representing 83.47 % of the Equity Share Capital of the Target Company as on the tenth working day after the closure of the Tendering Period.
